K. HOLDING FEE

The holding fee can only be accepted after the application for tenancy is approved.

TRA DISCLOSURE

I understand this agent is a member of Trading Reference Australia Pty. Ltd. (TRA) and may conduct a reference check with that organisation on myself and the company whose name appears on the lease.
